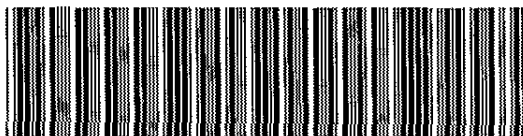




#### ARTICLE V - NATURE AND PURPOSE
