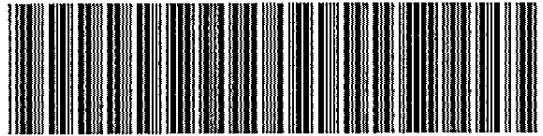

## **ARTICLES OF ORGANIZATION FOR DIVINE COMFORT HOMES OF FLORIDA, LLC.**

### **ARTICLE I            NAME**
