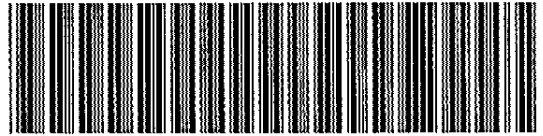


2. **Amendment to Name.** Article I of the Articles of Organization are hereby amended to read as follows:
