THESE ARTICLES OF DISSOLUTION are made this 9th day of August, 2007, by HOGAN & JORGENSEN L.L.C., a Florida limited liability company.

WITNESSETH

1.0 Name of the Company. The legal name of the Company is Hogan & Jorgensen L.L.C.

2.0 Formation of the Company. The Company filed its Articles of Organization on September 1, 2006, and the Florida Department of State assigned Document Number L06000086422 to the Company.

3.0 Date of Authorization. On June 26, 2007, the sole Members of the Company authorized the Company's dissolution by unanimous vote.


4.0 Sufficiency of Action for Dissolution. The Members' vote in favor of the Company's dissolution was unanimous and, as such, was sufficient to effectuate the Company's dissolution under Florida Statute Section 608.441(1)(c) and under the Company's Articles of Organization.


