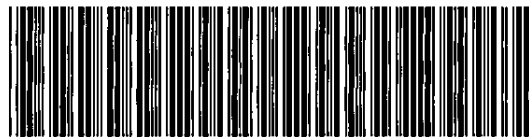

**ARTICLES OF ORGANIZATION
OF
CIBU OFFICE SUPPLY, LLC**

The undersigned, for the purpose of forming a multi-member limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, does hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be **CIBU OFFICE SUPPLY, LLC** ("Company").

ARTICLE II -- ADDRESS
