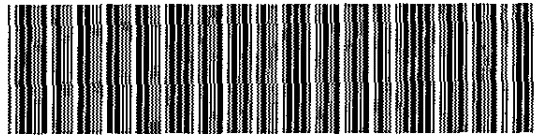

NAME**


**ARTICLE VII


