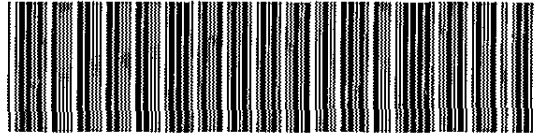

ARTICLE 1: NAME

The name of the limited liability company shall be CENTRAL FLORIDA DANCE CENTER, LLC.

ARTICLE 2: PRINCIPAL OFFICE

The mailing address and street address of the principal office is 1216 Winter Garden Vineland Road, Building 2, Unit 108, Winter Garden, Florida 34787.

ARTICLE 3: RESIDENT AGENT

The name and address of the resident agent is Rodney L. Russell, 1030 North Orange Avenue, Suite 102, Orlando, Florida 32801.

ARTICLE 4: MANAGEMENT

The company shall be managed by the members.

ARTICLE 5: PURPOSE

The company may engage in any lawful business.

The power to amend, alter or repeal these articles of organization shall be vested in the members. The articles of organization may be amended at any time and in any manner by the unanimous written consent of the members.

ARTICLE 11: CERTIFICATES

The company has the authority and shall issue Certificates of Membership to each member evidencing that member's interest in the company. Certificates of Membership shall be signed by a manager of the company.
