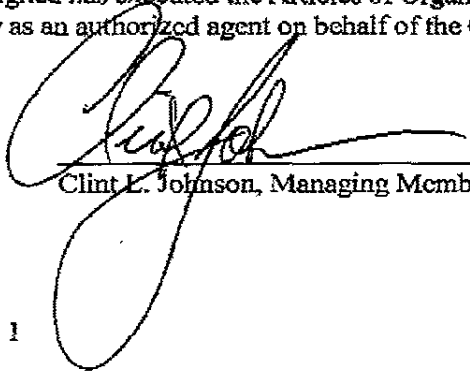

1. Name of Limited Liability Company. The name of the professional limited liability company is **THE JOHNSONLAW GROUP, PLLC** a Florida professional limited liability company (the "Company").
2. Period of Duration. The period of duration for the Company shall be perpetual.

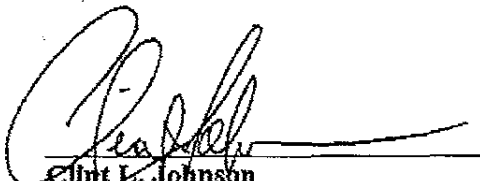

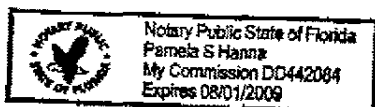
