

ARTICLES OF ORGANIZATION

OF

DAWN TROSSET, LLC.

I, the undersigned, being the Member and Organizer of the Limited Liability Company hereby being formed under Chapter 608 of the Florida Statutes, does hereby adopt the following Articles of Organization for the Limited Liability Company for the purpose of becoming a corporation under the laws of the State of Florida.

ARTICLE I: NAME

The name of this Limited Liability Company shall be:

ARTICLE IV: REGISTERED AGENT



ARTICLE XI: CONTINUITY OF EXISTENCE

If there later are more than one Member, the remaining Members of the Limited Liability Company, by the unanimous vote or consent of the Members (other than the Member who caused the Withdrawal Event), may continue the Limited Liability Company upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event which terminated the continued membership of a Member in the Limited Liability Company.
