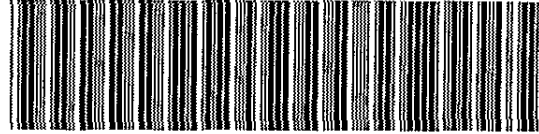

This organization is organized for the purpose of acquiring, developing, financing and managing real property.


