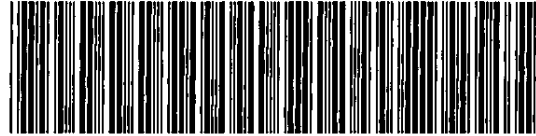

**HIGH SPRINGS, LLC**  
**ARTICLES OF ORGANIZATION**

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida does set forth the following:

**ARTICLE I - NAME**

The name of the Limited Liability Company is "HIGH SPRINGS, LLC".

**ARTICLE II - PERIOD OF DURATION**

The period of duration of the Limited Liability Company shall be from the date of filing of these Articles of Organization until dissolution of the Limited Liability Company pursuant to the provisions of the Florida Limited Liability Company Act.

**ARTICLE III - PURPOSE**

The Limited Liability Company is organized to engage in any and all businesses and activities permitted by the laws of the State of Florida. The Limited Liability Company shall have all of the powers vested in a Limited Liability Company organized and existing by virtue of such laws.

**ARTICLE IV - PRINCIPAL PLACE OF BUSINESS**

**ARTICLE V - REGISTERED AGENT**

**ARTICLE VI - ADDITIONAL MEMBERS**

Members may be admitted to the Limited Liability Company only upon the unanimous agreement of the then existing members.

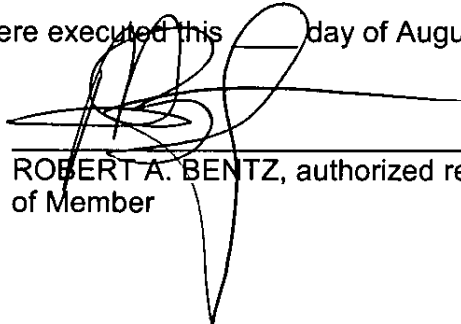
## **ARTICLE VII - CONTINUITY OF BUSINESS**

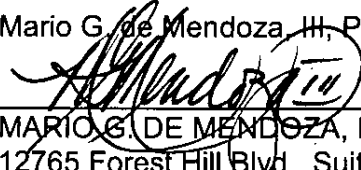
