The company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminated the continued membership of a member in the company, unless the business of the company is continued by unanimous vote of all the remaining members.

<u>ARTICLE IX - MANAGEMENT</u>

The company shall be managed by a manager in accordance with the regulations adopted by the members for the management of the business and affairs of the company, These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization.
