

ARTICLES OF ORGANIZATION

OF

FP&O, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be FP&O, LLC.

ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the company is 902 S. Alexander Street, Plant City, Florida 33563.

ARTICLE III -- DURATION

The company shall commence its existence on the date these articles of organization are filed by the F lorida D epartment of S tate or on a nother effective date as specified.
