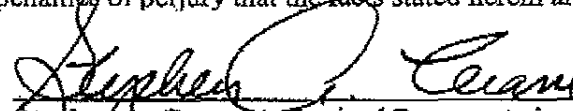
**ARTICLES OF ORGANIZATION
