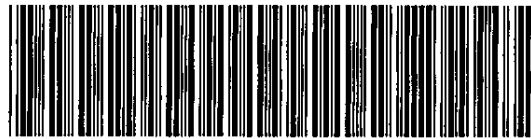

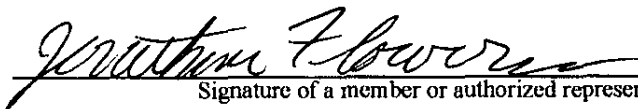

## **Transfer and assignment of membership interest**

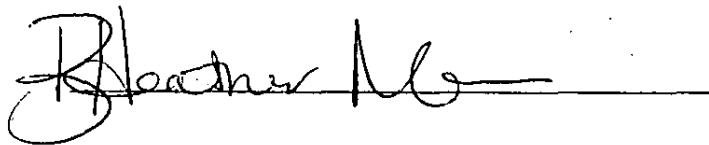
