**ARTICLES OF ORGANIZATION FOR
CENEGENICS MEDICAL INSTITUTE OF BOCA RATON, LLC.
A FLORIDA LIMITED LIABILITY COMPANY**

The undersigned, desiring to form a limited liability company under and pursuant to Florida Statute, Section 608.401 et. seq., entitled the Florida Limited Liability Company Act, does hereby adopt the following Articles of Organization for such company:

1. **NAME.** The name of this company shall be Cenegenics Medical Institute of Boca Raton, LLC.

2. **ADDRESS OF COMPANY.** The mailing and street address of the principal office of the Company is 3200 North Federal Highway, Suite 223, Boca Raton, Florida 33431.

3. **REGISTERED AGENT AND OFFICE.** The name and street address of the initial registered agent and office for the Company is as follows: JACK STEIN, located at 1499 West Palmetto Park Road, Suite 300, Boca Raton, Florida 33486.

4. **MANAGEMENT OF THE COMPANY.** The business of the Company shall be managed by ROBERT D. WILLIX, JR., and JOHN E. ADAMS, or such other manager as may be appointed by the members in accordance with the provisions of the Operating Agreement.

5. **PURPOSE OF COMPANY.** The Company is being formed to engage in any activity or business permitted under the laws of the United States and of the State of Florida and such other states in which the Company may engage in business.

6. **REGULATIONS OF COMPANY.** The members may adopt such Regulations governing the operations, and management of the Company, the admission of new members, the transfer of a member's interest and the termination of member(s). Regulations adopted by the Members or by the Manager(s) may be repealed or altered, new Regulations may be adopted by the Members, and the Members may prescribe in any Regulations made by them that such Regulations may not be altered, amended or repealed by the Manager(s).


