## ARTICLES OF ORGANIZATION OF RAHDERT, STEELE TITLE ASSURANCE, LLC

The undersigned certifies that Member has associated for the purpose of becoming a finite liability company, under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. We further declare that the following Articles shall give as the Charter and authority for the conduct of business of the limited liability company.

#### ARTICLE I - NAME

The name of the Company shall be RAHDERT, STEELE TITLE ASSURANCE, LLC, hereinafter referred to as "Company."

#### ARTICLE II - PURPOSE AND POWERS

- 6. To do everything necessary, proper, advisable, or convenient for the accomplishment of nay of the purposes, or attainment of any of the objects, or the furtherance of any of the powers set forth in these Articles, either alone or in association with others incidental or pertaining to, or going out of, or connected with its business or powers, provided the same shall not be inconsistent with the laws of the State of Florida.
  - 7. The Company is empowered to accept debt.

The several clauses contained in this statement of the general nature of the business or businesses to be transacted shall be construed as both purposes and powers of the Company, and statements contained in

each clause shall, except as otherwise expressed, be in no way limited or restricted by reference to or inference from the terms of any other clause. They shall be regarded as independent purposes and powers.
