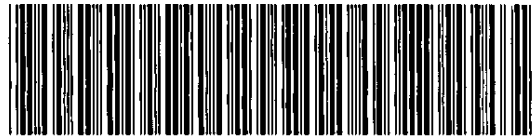

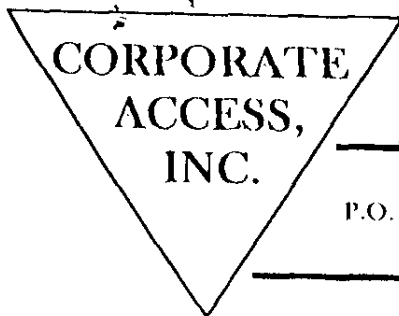

THIS IS TO CERTIFY THAT:

FIRST: This Amended Restated Articles of Organization amends and restates the Articles of Organization of Team Raydiance, LLC.

SECOND: The original Articles of Organization of Team Raydiance, LLC were filed with the Florida Department of State on September 8, 2006, and assigned Document Number L06000088243.

THIRD: The Articles of Organization of Team Raydiance, LLC are hereby amended and restated by deleting the existing Articles of Organization of Team Raydiance, LLC in its entirety and replacing it with the following:

**“ARTICLE I — NAME:**

The name of the Limited Liability Company shall be: Team Raydiance, LLC (the “Company”).

The mailing address and street address of the principal office of the Company shall be as follows:



**STATEMENT ACCEPTING APPOINTMENT AS REGISTERED AGENT**


