AMENDED AND RESTATED
ARTICLES OF ORGANIZATION OF
NOSO CONTROL, L.L.C.

The Articles of Organization for this Limited Liability Company were filed on September 8, 2006 and assigned document number L06000088770. Pursuant to the provisions of Florida Statutes §605.0202, this Florida Limited Liability Company, by and through its undersigned authorized representative, hereby amends and restates its Articles of Organization as follows:

ARTICLE I

Name

The name of the Limited Liability Company shall be NOSO CONTROL, L.L.C.

ARTICLE II

Term of Existence

The Limited Liability Company shall have perpetual existence.

ARTICLE III

Principal Office and Mailing Address
of the Limited Liability Company

The principal address and mailing address of the Limited Liability Company shall be 12914 Dupont Circle, Tampa, Florida 33626, with the privilege of having its offices (and branch offices) at other places within or without the State of Florida.

ARTICLE IV

Registered Agent and Office

The registered office of the Limited Liability Company is 12914 Dupont Circle, Tampa, Florida 33626. The registered agent at that address is MICHAEL E. MONSKY.

ARTICLE V

Management

The Limited Liability Company shall be managed by one (1) or more managers and is, therefore, a manager-managed company.

ARTICLE VII -
Membership Interests


The aggregate number of units of Membership Interests which the Limited Liability Company is authorized to issue is 10,000 units of voting Membership Interests (the "Voting Membership Interests"), and 10,000 units of non-voting Membership Interests (the "Non-Voting Membership Interests"). The preferences, limitations, and relative rights of the units of Membership Interests of the Limited Liability Company are as follows:

(1) Payment of distributions to holders of Voting Membership Interests and Non-Voting Membership Interests will be without discrimination or preference.

(2) Voting Membership Interests will have full voting rights with the holders thereof entitled to one (1) vote per unit thereof. None of the holders of Non-Voting Membership Interests will have any voting rights for any purpose, except as otherwise specifically provided in the Limited Liability Company's Operating Agreement, as may be amended and/or restated from time to time.

(3) Each of the Voting Membership Interests and the Non-Voting Membership Interests will have equal rights in the assets of the Limited Liability Company upon liquidation.

IN WITNESS WHEREOF, the undersigned authorized representative has executed the foregoing Articles of Organization on the 25 day of Feb, 2021, and in accordance with Section 605.0203(1)(b), Florida Statutes, the execution of this document constitutes an affirmation under the penalties of perjury that the facts stated herein are true. 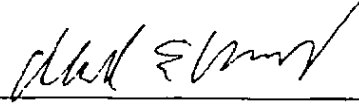

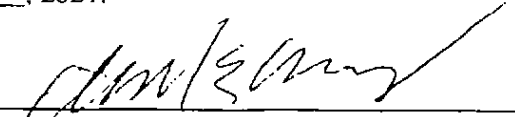
