
4. **MARITAL SETTLEMENT AGREEMENT.** The parties have entered into a Marital

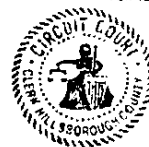
