**ARTICLES OF ORGANIZATION
OF
DA' GARAGE AUTO BROKERS, LLC.**

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida do hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the Limited Liability Company is, Da' Garage Auto Brokers, LLC.

ARTICLE II - DURATION

The Period of duration of the Limited Liability Company shall be from the date of filing until the first to occur of the following:

- 1) Thirty (30) years from the date of the filing of these Articles of organization with the Secretary of State, or
- 2) Dissolution of the Limited Liability Company pursuant to the provisions of the Florida Limited Liability Company Act.

ARTICLE III - PURPOSE AND POWERS

The purpose for which the Limited Liability Company is organized is to engage in any and all business and activities permitted by the laws of the State of Florida. The Limited Liability Company shall have all the powers vested in a Limited Liability Company organized and existing by virtue of such laws.

ARTICLE IV - ADDRESS OF PLACE OF BUSINESS

ARTICLE VI - CAPITAL CONTRIBUTIONS

The total amount of cash and a description of the agreed value of the property and other cash contributed to the Limited Liability Company are as follows: One Thousand and 00/100 Dollars (\$1,000.00) in cash and no other property is being contributed to the Limited Liability Company.

ARTICLE VII-ADDITIONAL CONTRIBUTIONS

The total additional contributions, if any, agreed to be made by all members and the times at which, or the events or happening of which, that shall be made, are as follows: No total additional contributions have been agreed to at the date of filing of these Articles of Organization. Additional contributions, if any, will be made upon majority agreement by the managing members of the Limited Liability Company.

ARTICLE VIII - ADDITIONAL MEMBERS

Members may admit additional members upon majority agreement of the then existing managing members.

ARTICLE IX - CONTINUITY OF BUSINESS

Upon death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in a Limited Liability Company, the business of the Limited Liability Company shall be dissolved unless there is an obtained consent of all remaining Managing Members of the Limited Liability Company.

ARTICLE X - MANAGEMENT

The Limited Liability Company is to be managed by a manager or managers in accordance with regulations adopted by the Managing Members of the management of the business and affairs of the Limited Liability Company. These regulations may contain any provisions for the regulation and management of the affairs of the Limited Liability Company not inconsistent with the law or these Articles of Organizations, or any amendments thereto.
