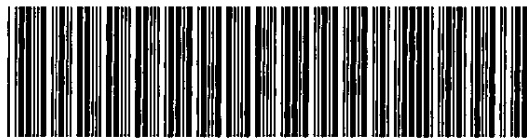

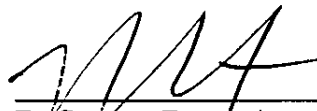
ARTICLE VI

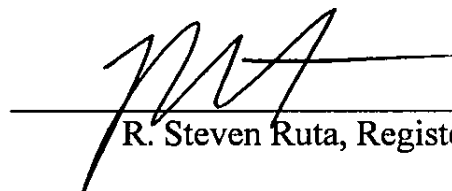
