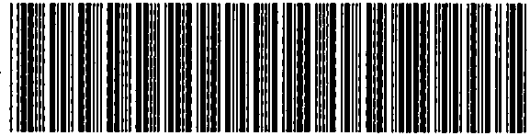



The undersigned hereby forms and establishes a limited liability company pursuant to Chapter 608, Florida Statutes, as follows:

**ARTICLE I**


**ARTICLE III**


