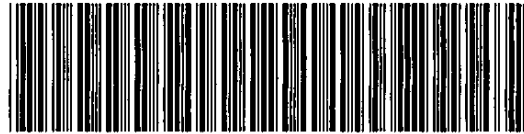

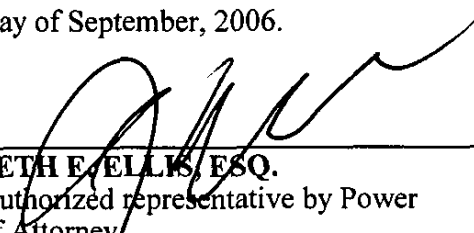
ARTICLE VI
