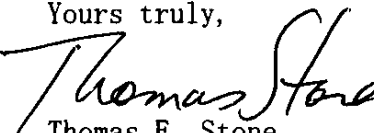

The undersigned member pursuant to the provisions of the Florida Limited Liability Company Act, adopt the following Articles of Organization.

ARTICLE I

NAME

The name of the corporation shall be HUGH'S LAWN CARE AND TREE SERVICE, LLC.

ARTICLE II

REGISTERED OFFICE AND AGENT

The company shall terminate on September 5, 2016.

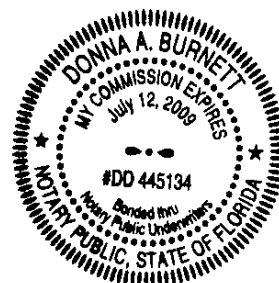
