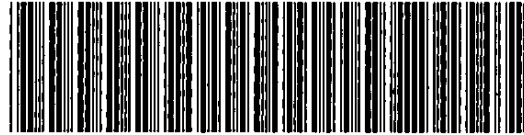

ARTICLE I-NAME

ARTICLE VI-MANAGEMENT OF THE COMPANY

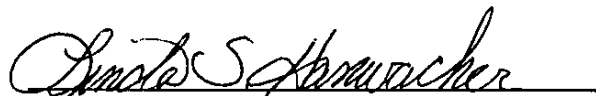
