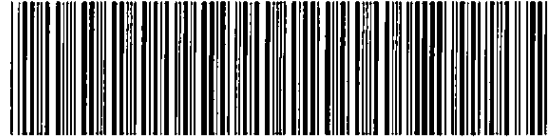

**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF
BLUMOON CONSTRUCTION, LLC**

BLUMOON CONSTRUCTION, LLC, (the "*Company*"), a for profit corporation organized and existing under the laws of the State of Florida, in order to amend its Articles of Organization in accordance with the requirements of §605.0202, Florida Statutes, does hereby certify as follows:

1. The Articles of Organization of the Company were filed with the Secretary of State of the State of Florida on the 12th day of September, 2006, under the name "BLUMOON CONSTRUCTION, LLC."

2. The amendment to the existing Articles of Organization being affected hereby is a change in the name of the corporation from "BLUMOON CONSTRUCTION, LLC" to "BLUMOON LIMITED, LLC."

3. These Articles of Amendment were unanimously approved by joint written action of the Managers and the Members of the Company the 1st day of December, 2023.

4. After payment of all required taxes and fees, these Articles of Amendment are to be effective immediately upon filing with the Secretary of State of the State of Florida, at which time the existing Article I of the Articles of Organization of the Company shall be deleted in its entirety and the following Article I shall be substituted in its place and stead:

**"ARTICLE I
Name**

The name of this corporation shall be: "BLUMOON LIMITED, LLC"
