ARTICLES OF ORGANIZATION for C.E.L. ENTERPRISES, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be C.E.L. Enterprises, LLC ("Company").

ARTICLE IX - EFFECTIVE DATE


