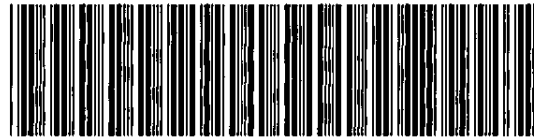

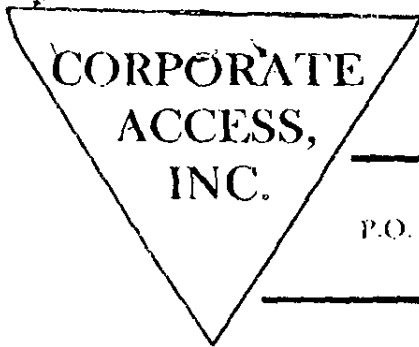

ARTICLE III - MANAGEMENT



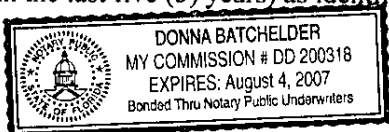


