ARTICLES OF ORGANIZATION
OF
JKMWC PARTNERS, LLC

1. **Name.** The name of this limited liability company is JKMWC PARTNERS, LLC, a Florida limited liability company (the "Company").

2. **Duration.** The Company shall have perpetual existence, commencing on the date of filing of these Articles of Organization.

3. **Purpose.** The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.

4. **Place of Business.** The street address and mailing address of the Company's principal office is 9625 Wes Kearney Way, Riverview, Florida 33569.

5. **Registered Agent and Office.** The name of the initial registered agent of the Company is James M. Reed. The street address of the initial registered agent of the Company is 9625 Wes Kearney Way, Riverview, Florida 33569.


6. **Contributions to the Company.** No cash or property has been contributed to the Company by its members. No contributions have been agreed upon.

7. **Additional Members.** Additional members to the Company may be admitted, but only upon the consent of the members of the Company at the time admission is sought.

8. **Termination of Membership.** Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the Company shall be dissolved unless all remaining members agree in writing to continue the business of the Company.

9. **Management of the Company.** The Company shall be managed by its members in accordance with the operating agreement adopted by all of the members. Bing Kearney shall be the initial Managing Member and shall have full power and authority to act for and on behalf of the Company, including, without limitation, to enter into contracts, open and close bank accounts, incur and pay debts and expenses, file papers with the Internal Revenue Service, and engage professionals and other advisors, and all persons may rely on these Articles of Organization to deal directly with Bing Kearney on all matters relating to the Company.

The undersigned executed these Articles of Organization on the 13 day of August, 2006.




