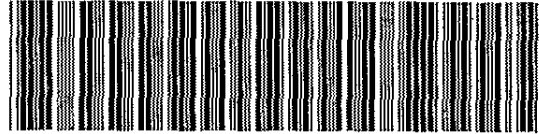

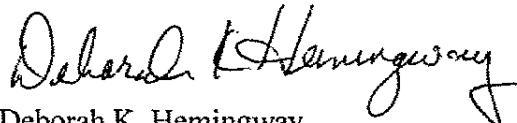

**ARTICLES OF ORGANIZATION OF

ARTICLE I. NAME

The name of the Limited Liability Company ("Company") is **SCHOOL OF FISH, L.L.C.**

ARTICLE IX. MEMBERS RIGHT TO CONTINUE BUSINESS

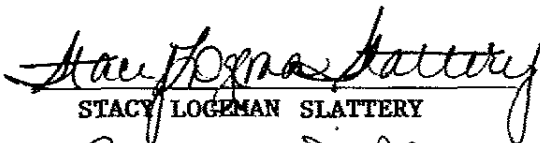

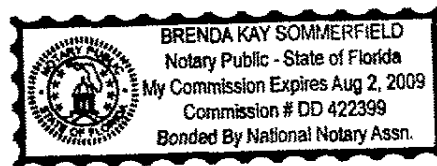
