# **ARTICLE 1 - NAME**

The name of the limited liability company shall be <u>SWEET BAY FASHIONS LLC</u> ("Company").

### **ARTICLE 2 - ADDRESS**

The principal place of business of the Company in Florida shall be 130 Via Palacio, Palm Beach Gardens, FL 33418 and the mailing address shall be the same.
