

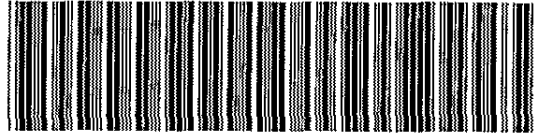

**ARTICLES OF ORGANIZATION
PEPE AND JULIO'S CONSTRUCTION, L. L.C.**

The undersigned adopts the following Articles of Organization for the purpose of becoming a limited liability company under the Florida Limited Liability Company Act:

**ARTICLE I
Name**

The name of the limited liability company, referred to in these Articles as "Company" is PEPE AND JULIO'S CONSTRUCTION, L. L. C.

**ARTICLE II
Duration**

The company shall dissolve on December 31, 2036.

**ARTICLE III
Purpose**

The purpose for which this Company is organized is to perform construction purposes, as well as to transact any or all lawful business for which limited liability companies may be organized under the Florida Limited Liability Company Act.

**ARTICLE IV
Principal Address**

The address of Company's principal place of business in Florida is, 3029 Hickory Court, Zolfo Springs, Florida, 33890, and its mailing address is Post Office Box 439, Zolfo Springs, Florida, 33890.

**ARTICLE V
Registered Agent and Office**

**ARTICLE VI
Capital Contributions**

The total amount of cash contributions is \$1,000.00.

Contributions to the Company by each of the two initial members are as follows:

- (a) Julio Avila, has made a cash contribution of \$500.00.
- (b) Leandro D. Castro, has made a cash contribution of \$500.00.

ARTICLE VII
Initial Members

The initial members are identified as follows:

ARTICLE VIII
Admission of New Members

Members shall have the right to admit new members. Additional members may be admitted only on the unanimous written consent of existing members, and the existing members shall determine the amount and nature of contributions by new members at the time the new members are admitted. Provided, however, the original two members may transfer all or part of their interest to immediate member of their family and these family members shall automatically be admitted as members.

ARTICLE IX
Remaining Members

The remaining members of the company may continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the limited liability company.

ARTICLE X
Management

The Company shall be managed by Julio Avila, Manager/Member and Leandro D. Castro, Manager/Member.

ARTICLE XI
Additional Provisions

The company is to be a manager managed company. The company shall have two managers. Julio Avila and Leandro D. Castro shall serve as initial managers. The managers shall be elected by the members according to the Operating Agreement.

ARTICLE XII
Additional Provisions

The power to adopt, alter, amend, or repeal the regulations of the Company is vested entirely in the members listed in Article VII.
