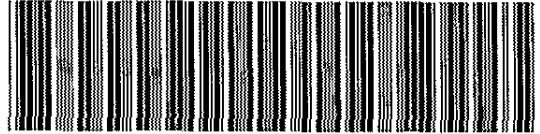

Pursuant to Section 608.407 of the Florida Limited Liability Company Act, the undersigned, as a Member of Hite-Riggins Builders, LLC (hereinafter the "Limited Liability Company"), does hereby make, subscribe, acknowledge and file these Articles of Organization for the purpose of becoming a Limited Liability Company under the Laws of the State of Florida.

ARTICLE I. NAME

ARTICLE IV. MANAGEMENT


The Limited Liability Company shall be a member-managed Limited Liability Company. The members of the Limited Liability Company may elect or appoint one or more members to serve
