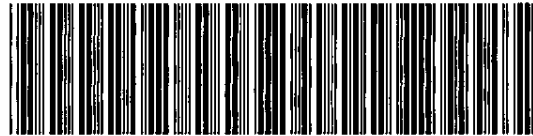



Pursuant to Florida Statutes §608.441, this Florida limited liability company submits the following articles of dissolution:


- FIRST: The name of the limited liability company as currently filed with the Department of State is Worldly Watches LLC:
