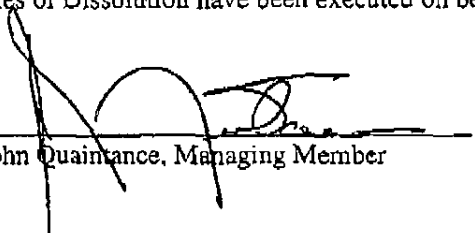

**ARTICLES OF DISSOLUTION

The undersigned, as managing member ("Managing Member") of Florida Partners Professional Services, LLC, a Florida limited liability company, and pursuant to the provisions of the Florida Limited Liability Company Act, as amended, do hereby certify as follows:

1. Name. The name of the limited liability company is Florida Partners Professional Services, LLC (the "Company").
2. Formation. The Articles of Organization of the Company were filed on September 15, 2006, and assigned document number L06000090949.
3. Approval of Dissolution. The dissolution of the Company was approved on May 1, 2009, by a vote of the Members of the Company in accordance with the Company's Operating Agreement. The effective date of the dissolution of the Company shall be the date of filing of these Articles of Dissolution with the Secretary of State of the State of Florida.
4. Description of Occurrence. A description of the occurrence that resulted in the Company's dissolution is that the Members of the Company have agreed by written consent to dissolve the Company in accordance with Section 608.441(1)(c) of the Florida Statutes.
5. Debts, Obligations and Liabilities and Property. All debts, obligations and liabilities of the Company have been paid or discharged.
6. Distribution of Property. All remaining property and assets of the Company have been returned to the person or persons that formed the Company.
7. Pending Suits. There are no suits pending against the Company in any court.
