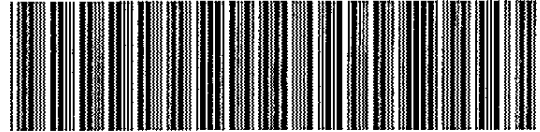

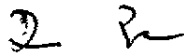

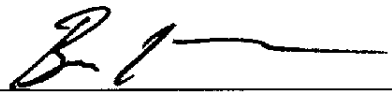
**ARTICLES OF ORGANIZATION
OF
THE HARVEST COMPANIES LLC**

1. Name. The name of this limited liability company is THE HARVEST COMPANIES LLC, a Florida limited liability company (the "Company").
2. Duration. The Company shall have perpetual existence commencing on the filing of the Articles of Organization with the State of Florida and continues even though a membership of a member is terminated.
3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida, including to invest in, buy, own, develop, lease or sell real estate and make improvements thereon, to act as a broker and act as a management service for elder and nursing care, and to engage in business and such other lawful activities as are reasonably necessary, convenient or incidental to these purposes.
4. Place of Business. The mailing and street address of the Company's principal office is 12933 Bald Cypress Lane, Naples, Florida 34119.
5. Registered Agent and Office. The name of the initial registered agent of the Company is Bruce L. Folkerth, Sr. The street address of the initial registered agent of the Company is 12933 Bald Cypress Lane, Naples, Florida 34119.
6. Additional Members. Additional members to the Company may be admitted, but only upon the unanimous consent of all members of the Company at the time admission is sought.
7. Management of the Company. The Company shall be managed by its manager, in accordance with the Regulations adopted by all of the members. The name and address of the initial manager, who is also a member of the Company is: Bruce L. Folkerth, Sr. whose post office address is 12933 Bald Cypress Lane, Naples, Florida 34119. The initial manager may elect to appoint additional managers in writing.
8. Voting. The Company is authorized to issue membership interests with voting rights and membership interests without voting rights.
9. Certificated Interests. The members' interests in the Company may be evidenced by certificates.
10. Member's Rights. Pursuant to section 608.4235 of the Florida Statutes, no member of the Company other than a manager shall be an agent of the company solely by virtue of being a member, and no member other than a manager shall have authority to incur debt or contractual liability on behalf of the company solely by virtue of being a member.
