ARTICLES OF ORGANIZATION OF

Article I

The name of the limited liability company ("Company") is RIVER OAKS FARM, LLC.

Article II

The mailing and street address of the Company's principal office is 1170 Mandy Lane, Astor, Florida 32102. The members shall have the power and authority to establish branch offices, or to change the location of the principal office, to such other places as the members may designate.

Article III

The period of duration for the Company is perpetual.

Article IV

The name of the Company's initial registered agent in Florida is GIGHA STEINMAN . The address of the Company's registered office in Florida is 1170 Mandy Lane, Astor, FL 32102. The mailing address is P. O. Box 324, Astor, FL 32102.

Article V

The Company is to be managed by the Members. The Initial Managing Member will serve until the first annual meeting of the Members. The Initial Managing Member is identified as follows:

Members of the Company have the right to admit new members. Additional members may be admitted only on the unanimous written consent of the existing members, and the existing members shall determine the amount and nature of contributions by new members at the time the new members are admitted.

The remaining members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Company as provided in the Company's Regulations.

**Article VIII**

The power to adopt, alter, amend, or repeal the Regulations or Operating Agreement of the Company is vested entirely in the Members and any such adoption, alteration, amendment or repeal must be done by unanimous written consent of the Members.


