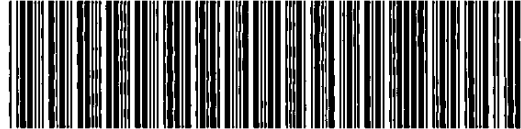

ARTICLE I

NAME

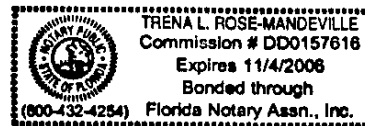
