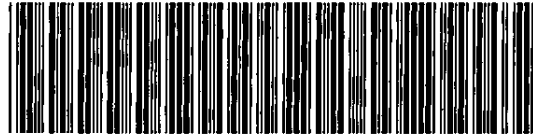

ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

ARTICLE I -- NAME

The mailing address and street address of the principal office of the company is C/O Joseph G. Thomas, 106 Via Santa Cruz, Jupiter, FL 33458.

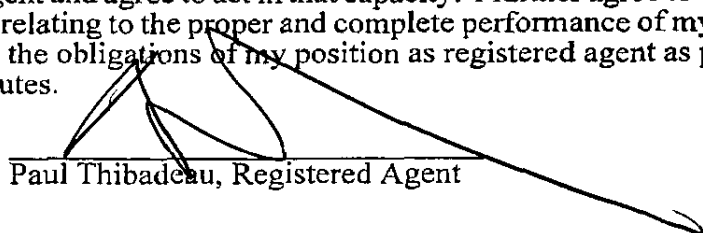
ARTICLE III -- DURATION
