

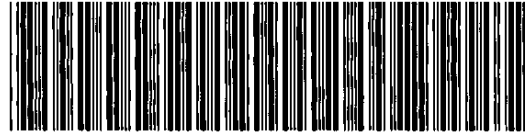

**ARTICLES OF ORGANIZATION
OF CISAN FAMILY LLC**


