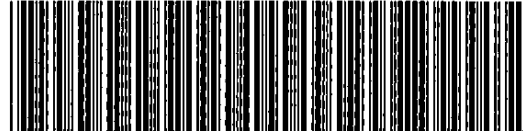

The undersigned as member, manager, or authorized legal representative of the Members, of a limited liability company to be formed pursuant to Chapter 608, Florida Statutes, hereby execute these Articles of Organization for the formation of **MONIKA ZIMMERMANN, LLC**, a Florida limited liability company.

ARTICLE I - NAME

The name of this company shall be **MONIKA ZIMMERMANN, LLC**, hereinafter referred to as "Company".

ARTICLE II - ADDRESS AND PLACE OF BUSINESS

The mailing address and principal place of business for the Company is 600 Casler Avenue, Clearwater, Florida 33755.

ARTICLE III - PERIOD OF DURATION

The Company shall begin existence upon subscription and acknowledgment of these Article and shall continue in the perpetuity, or until dissolved in a manner provided by law or by an operating Agreement adopted by the Members of the limited liability company.

ARTICLE IV - PURPOSE

The Company may engage in the pursuit of any or all lawful business activities for which limited liability companies may be formed under the law of the State of Florida.

ARTICLE V - MANAGEMENT

The management of the Company shall be vested in the Members. The Members shall have all rights and powers generally granted to them by Chapter 608, Florida Statutes, and as may be further modified are granted in an Operating Agreement, which may be adopted unanimously by the Members. ARTICLE VI - ADMISSION OF MEMBERS

The initial Members of the Company are as set forth herein. The admission of additional Members shall be accomplished only by the unanimous vote of the initial Members, except as otherwise stated in an Operating Agreement adopted by the initial Members.

ARTICLE VII - CONTINUATION OF BUSINESS

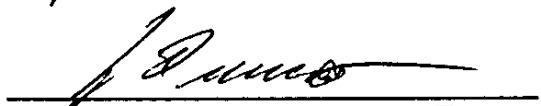

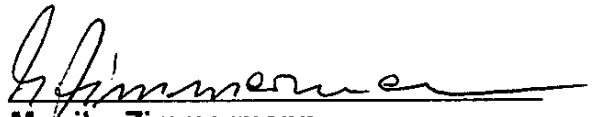
