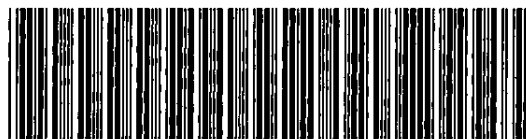



ARTICLES OF ORGANIZATION FOR FLORIDA LIMITED LIABILITY COMPANY

The undersigned, a subscriber to these Articles of Organization, a natural person competent to contract, hereby presents these Articles for the formation of a limited liability company pursuant to the laws of the State of Florida.


