ARTICLES OF ORGANIZATION OF UNDERSTANDING U, P.L.

A Florida Professional Limited Liability Company

I, the undersigned, certify that I hereby organize for the purpose of becoming a Professional Limited Liability Company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of professional limited liability companies. I further declare that the following Articles shall serve as the Articles of Organization and authority for the conduct of business of the Professional Limited Liability Company (the "Company").

ARTICLE I Name

The name of the Company shall be UNDERSTANDING U, P.L.

ARTICLE II Address

The mailing address and street address of the principal office of the Company is: 24124 N.W. 78th Avenue, Alachua, FL 32615.

ARTICLE III Registered Agent, Registered Office & Registered Agent's Signature

The address of the initial registered office of the Company is 24124 N.W. 78th Avenue, Alachua, FL 32615, and the name of the company's initial registered agent at that address is Diane P. Wertz.

Having been named as registered agent and to accept service of process for the above-stated Limited Liability Company at the place designated in this certificate, I hereby accept the appointment as Registered Agent and agree to act in this capacity. I further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties, and I am familiar with and accept the obligations of my position as registered agent as provided in Chapter 608, F.S.

The purpose of the Company is to practice the profession of speech-language pathology. The sole and exclusive professional services to be rendered by the company are to:

- 1. Provide speech and language diagnostic and intervention services to patients.
- 2. Provide consultative services to referring parents and school districts, including in-service training.
- 3. Actively participate in coordination of patient care through communication with families and referring professionals, schools and agencies as needed.
 - 4. Oversee speech pathology and practicum students.
 - 5. Provide graduate student and guest lectures.
- 6. Develop a curriculum for speech-language pathology students with expected outcomes and competencies.
- 7. Serve a central role in organizing program procedures and systems and supervising the daily ongoing operational needs of the program.
- 8. Manage a speech-language pathology program to ensure quality and assurances.
- 9. Collaborate among university and private sectors to provide quality service to clients.
- 10. Promote speech-language pathology, and scientific research and knowledge; to furnish related laboratory and clinical services; and to own real and personal property, enter into contracts, and engage in any lawful business necessary for the rendering of the professional speech-language pathology services.
- 11. Do everything necessary, proper, or convenient to accomplish any of the purposes set forth in these articles, and to every other act incidental to company purposes which is not forbidden by Florida laws or by the provisions of these articles of organization.

ARTICLE V Exercise Of Powers

The purpose of the Company shall be carried out only through officers, employees, members and agents, each of whom is licensed or otherwise legally qualified to render professional speech-language pathology services in the State of Florida. All Company powers shall be exercised by or under the authority of, and the business and affairs of the Company shall be managed under the direction of the member of the Company. This Article may be amended from time to time in the regulations of the Company by a unanimous vote of the members of the company.

ARTICLE VI Managing Member

Management of the Company is reserved to its Managing Member. The name and address of the Managing Member is Diane P. Wertz., 24124 N.W. 78th Avenue, Alachua, FL 32615.

ARTICLE VII Membership Restrictions

Members shall have the right to admit new members by unanimous consent. Contributions required of new members shall be determined as of the time of admission to the Company. A member's interest in the Company may not be sold or otherwise transferred except with unanimous written consent of all members.

On the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or the occurrence of any other event that terminates the continued membership of a member in the Company, the remaining members shall have the right to continue the business on unanimous consent of the remaining members.

ARTICLE VIII Duration

The Company shall exist until dissolved in a manner provided by law, or as provided in the regulations adopted by the members.
