

ARTICLES OF ORGANIZATION OF
CSMYL, LLC
A FLORIDA LIMITED LIABILITY COMPANY

The undersigned, in forming a Florida Limited Liability Company ("Company") under the Florida Limited Liability Company Act, Chapter 608 of the Florida Statutes, hereby adopt the following Articles of Organization for such Company:

ARTICLE I - NAME

The name of the Company is CSMYL, LLC.

ARTICLE II - DURATION

The existence of the Company shall commence as of the date these Articles of Organization are filed by the Department of State and shall continue in perpetuity from that date unless earlier dissolved in accordance with the provisions of Article VI herein.

ARTICLE III - ADDRESS

The mailing address and street address of the principal office of the Company is 10731 SEA CLIFF CIRCLE, BOCA RATON, FLORIDA 33498.

ARTICLE IV - INITIAL REGISTERED AGENT

ARTICLE V - ADDITIONAL MEMBERS

Additional members may be admitted to the Company only upon the unanimous written consent of all of the then existing Members of the Company, which consent may be unreasonably withheld.

The management of the Company shall be vested in it's managers which shall consist of one or more individuals duly elected by the Members in the manner set forth in the Regulations of the Company. 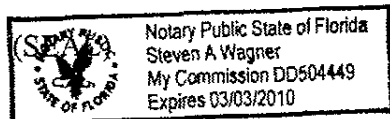


