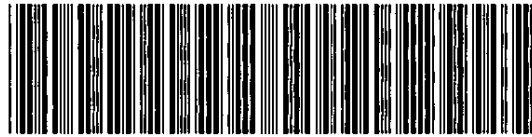

ARTICLE I

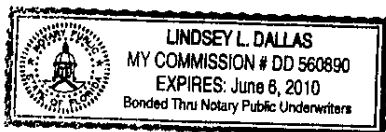

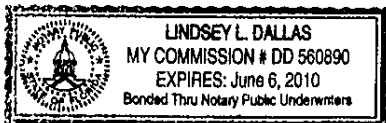
