MEMBERSHIP



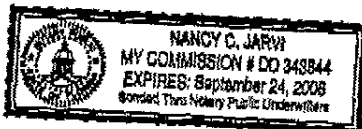


