

ARTICLES OF ORGANIZATION OF U.S. WOOD PRODUCTS, LLC

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I - Name

The name of the limited liability company (hereinafter referred to as the "Company") is "U.S. Wood Products, LLC."

ARTICLE II - Address

The mailing address and street address of the principal office of the Company is 10200 S.E. 42nd Court, Belleview, Florida 34420.

ARTICLE III - Duration

The period of duration for the Company shall be perpetual.

ARTICLE IV - DESIGNATION OF REGISTERED AGENT INITIAL ADDRESS OF REGISTERED OFFICE

The initial Registered Agent is designated as JOEL A. MOON, III. The Registered Agent of the corporation may be changed at any time by a vote of the Members without an amendment of these Articles.
