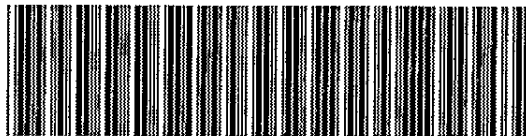



The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

**ARTICLE I - Name**

The name of the limited liability company (hereinafter referred to as the "Company") is "U.S. Wood Products, LLC."

**ARTICLE II - Address**

The mailing address and street address of the principal office of the Company is 10200 S.E. 42<sup>nd</sup> Court, Belleview, Florida 34420.

**ARTICLE III - Duration**

The period of duration for the Company shall be perpetual.

**ARTICLE IV - DESIGNATION OF REGISTERED AGENT

**ARTICLE V - Management**


The Company is to be managed by the members.


