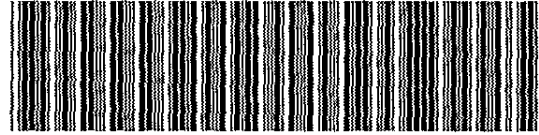


**ARTICLE V
